

Ordinance No. 2023-01

AN ORDINANCE AMENDING TITLE 7, CHAPTER 5 (6-11) ENTITLED SOLID WASTE FEES OF STOCKPORT MUNICIPAL CODEBOOK OF ORDINANCES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STOCKPORT, IOWA:

Section 1. AMENDMENTS

AMENDMENT 1. Title 7, Chapter 5 (Solid Waste Fees) Section 1 of the City of Stockport Municipal Codebook of Ordinances is hereby amended by adding the following paragraph:

Section 1.

The Council may review the garbage fee quarterly to adjust the garbage fee in proportion to the amount charged by the service provided.
