

# Ordinance No. 2022-02

City of Stockport – Summary of Ordinance #2022-02

The City Council of the City of Stockport, Iowa, adopted Ordinance #2022-02 at a special City Council meeting held on June 8, 2022. The content of the Ordinance is summarized in its title as follows:

**AN ORDINANCE AMENDING TITLE 6, CHAPTER 11 WATER RATES SECTION 1 (6-11-1) ENTITLED WATER BILLING AND PAYMENTS OF THE CITY OF STOCKPORT MUNICIPAL CODEBOOK OF ORDINANCES.** The bills for water service are due and payable at City Hall on the date of issue. The past due date shall be the fifteenth (15<sup>th</sup>) day of the month. Past due notices will be mailed out on the 16<sup>th</sup> day of the month showing a disconnect date of the twenty-eighth (28<sup>th</sup>) of the same month and a delayed payment charge of ten percent (10%) if payment has not been received. If the 28<sup>th</sup> of the month is a City Hall non-business day the services will be disconnected on City hall’s next business day. If on the day of disconnection the shut-off cannot occur for any reason and debt continues to accrue for up to three months, the debt will be assessed to the responsible party’s taxes. The effective date of the Ordinance is July 1, 2022.
