

**Stockport City Council Public Hearings and Meeting Minutes**  
**Monday, June 2, 2025 | 6:00 PM**

The Stockport City Council held a public hearing and their regular monthly meeting on Monday, June 2, beginning at 6:00 PM. The meetings were led by Mayor Garrett Filson. Council members present included Madge Clark, Terry Dorothy (remotely), and Tanya McClaran, establishing a quorum. Council member Nathan Padget was absent. City Clerk Dani Murphy recorded the minutes.

**Motion:** Dorothy moved to close the public hearing at 6:15 PM. Clark seconded. Motion carried unanimously.

**Public Comments**

No community members were present.

**Reports**

- **Maintenance Report** – The park will be sprayed for gnats before the Farmers Market.
  - **Sewer Rehabilitation Report** – Jim Warner provided an update on the Lagoon Rehabilitation Project. A large crack was found in a pipe, and replacement is estimated to cost \$8,000.
- **Utilities Report** – Both accounts over 61+ days delinquent are considered abandoned bills.
- **City Clerk Report** – Dani Murphy discussed the possibility of offering a sewer adjustment for residents filling swimming pools, so the water usage would not be counted toward sewer billing. The council agreed to proceed with implementing this adjustment.

**Consent Agenda**

- **Minutes Approval:** Dorothy moved to approve the minutes from May 12, 2025. Clark seconded. Motion carried unanimously.
- **Treasurer's Report:** The May Treasurer's Report was reviewed. McClaran moved to approve the report. Clark seconded. Motion carried unanimously.
- **Bill Payments:** The council reviewed current bills. Dorothy moved to approve payment of all bills. Clark seconded. Motion carried unanimously.

## Old Business

- **Scenic Drive Festival** – Stockport will host a movie night on the Friday of the festival at dusk.
- **Library Amazon Usage** – The business account will remain active and continue to be billed to all departments.

## New Business

- **Council Seat Vacancy by Appointment**  
**Motion:** McClaran moved to appoint Frank Nelson to the council seat vacancy, term ending December 2025. Dorothy seconded. Motion carried unanimously. Frank Nelson was sworn in.
- **Avenue of Flags**  
**Motion:** Dorothy moved to approve up to \$500 for the purchase of new flags. McClaran seconded. Motion carried unanimously.
- **Clerk Position**  
Clerk duties will be temporarily divided, with Madge Clark serving as a 1099 employee. A job opening for the main Clerk position will be posted and open for two weeks. Mayor Filson is authorized to post additional listings if needed.
- **Motion:** Dorothy moved to approve Madge Clark, as a 1099 employee, to perform various city tasks—including but not limited to deposits, monthly reconciliation, and special projects—at a rate of \$50/month. The responsibility and liability for these tasks will remain under the jurisdiction of the City Clerk, with final approval of assignments remaining with the City Council. McClaran seconded. Motion carried unanimously.
